PROJECT DESCRIPTION

The proposed project is to construct a roof deck and a flight of stairs from the fourth floor to the roof and add three Accessory Dwelling Units at the ground floor and basement level of an existing four-story, six-unit residential building undergoing seismic retrofitting.

PER SECTION 140 OF THE PLANNING CODE the subject property is required to have windows of each unit face directly on an open area no less than 25 feet in every horizontal dimension, with an increase of five feet in every horizontal dimension at each subsequent floor immediately above. The dimensions of the open area may be reduced to 15 feet in width and depth for Accessory Dwelling Units. The subject property has an existing rear yard that is 8 feet-9 inches in depth and 31 feet in width; two of the proposed accessory dwelling units will face onto that noncomplying rear yard, which is less than the minimum 15 foot rear yard required for reduced dwelling unit exposure, thereby requiring an exposure variance.

PER SECTION 134 OF THE PLANNING CODE the subject property is required to maintain a rear yard depth of 15 feet. The existing building encroaches 6 feet-3 inches into the required rear yard and therefore the proposed flight of stairs at the rear of the building are located in the required rear yard and require a variance.




APPEAL INFORMATION
